**What is Registration for?**

Individual Home Care is a regulated activity, and providers must be registered to work in people's homes. Individual Home Care providers are self employed or employed by the people they look after (or their representative). They provide personal care and personal support for up to 48 hours each week.

**What does Registration mean?**

Applicants have to provide identifying details and information, including photo ID. They have to: provide the names of two referees, an employer's reference and a character reference; a statement from their doctor to say they are medically fit for the role; evidence of a criminal record (DBS) check; evidence of relevant qualifications and/or basic training: First Aid, Moving and Handling, Safeguarding, Food Hygiene, Infection Control, or equivalent training. Registered individual carers also have to declare who they are working for/with, how many hours and their hourly rate. They have to keep the Commission up to date with changes to any of this information.
