Jersey Care Commission Chair's Report May 2023

1.0 Meetings with the Chief Inspector (CI)

I have continued meeting with the Chief Inspector on a weekly basis, via Teams. These meetings have addressed both strategic and operational matters, including regulatory and workforce issues, interface with SPPP, preparations for inspections of services new to regulation and the preparations for the May Board and Workshop.

2.0 Recruitment of Commissioners

The process to appoint new Commissioners is underway, with final interviews scheduled for 31 May. At the closing date, i.e., 14 April, there were 22 completed applications. Seven candidates have been shortlisted. The Interview Panel includes myself, Tom Walker, Deputy Chief Executive, Dr Matthew Doyle, GP and Dr Patricia Tumelty, Executive Director, MIND Jersey. The recruitment is being overseen by the Jersey Appointments Commission and I am grateful to Helen Ruelle JAC, for her advice, guidance, and support.

3.0 Isle of Man

On 17 April the Chief Inspector, Deputy CI and I had a conference call with Julie King, Executive Director of Safety Quality and Engagement, Department of Health and Social Care, Isle of Man. The conversation focused on areas of mutual interest, including inspection activity. We recognised the merits of building a closer working relationship around areas where we may be able to support each other. I have extended an invitation to Julie to meet the Commission in September.

4.0 Farewell to Alison Allam and Siân Walker-McAllister

As this is Alison's and Siân's final Board meeting, I wish to place on record my sincere thanks and appreciation of the excellent contributions they have both made to the work of the Commission since joining the Board in May 2017.
