Small provider means a home care service that provides an aggregate amount of care to all its care receivers of no more than 112 hours in any week;

Medium provider means a home care service that provides an aggregate amount of care to all its care receivers of more than 112 hours but not more than 600 hours in any week;

Medium plus provider means a home care service that provides an aggregate amount of care to all its care receivers of more than 600 hours but not more than 2,250 hours in any week;

Large provider means a home care service that provides an aggregate amount of care to all its care receivers' home care of more than 2,250 hours in any week.

**If a provider is registered after 31st March in any year the fee payable is as follows –

- (a) where the application is received between 1st April and 30th June, 75% of the fee otherwise payable but for this paragraph;
- (b) where the application is received between 1st July and 30th September, 50% of the fee otherwise payable but for this paragraph; and

⁽c) where the application is received between 1st October and 31st December, 25% of the fee otherwise payable but for this paragraph.
